#### **Structure of the OIS ELA Program:**

#### **Grades 5&6:**

- Heterogeneously grouped (mixed ability) English Language Arts Instruction that is delivered in a Reading and Writing Workshop Model. This includes vocabulary acquisition and grammar instruction as well as comprehension skills/strategies. Social and emotional learning is embedded throughout the curriculum.
- Homogeneously grouped (like ability) small group guided reading instruction.
- Tiered Interventions and supports as needed.
- 2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Conferences will be held: 11/7, 11/13 and 3/12
- 3. Provide parents with frequent reports on their children's progress.
